Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Ion Exchange WTS (Bangladesh) Ltd., which comprise the statement of financial position as at 31 March 2019, and the statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Company as at 31 March 2019, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs), the Companies Act 1994 and other applicable laws and regulations.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). 01 The company and nature of business

Ion Exchange WTS (Bangladesh) Limited is a private limited company incorporated on 12 April 2003 in Bangladesh under the Companies Act, 1994 vide incorporation # C -48888 (872)/2003 with the style of ION exchange Water Treatment Services (Bangladesh) Limited, which is renamed by ION Exchange WTS (Bangladesh) Ltd. The registered office of the company is located at Banani, House # 07, Road # 05, Block # F, Dhaka-1213, Bangladesh. The prime objective of the company is trading and servicing of water and waste water treatment plants.

1.01 Components of financial statements

The financial statements comprise the following:

- (i) Statement of financial position as at 31 March 2019;
- (ii) Statement of profit or loss and other comprehensive income for the year ended 31 March 2019;
- (iii) Statement of changes in equity for the year ended 31 March 2019;
- (iv) Statement of cash flows for the year ended 31 March 2019; and
- (v) Notes to the financial statements as at and for the year ended 31 March 2019.

02 Significant accounting policies and disclosures

2.01 Basis of preparation and presentation of financial statements

The financial statements have been prepared under historical cost convention and after due compliance with International Financial Reporting Standards (IFRS), the Companies Act, 1994 and other relevant local laws and regulations as applicable.

2.02 Cash flow statement

Cash flow statement is prepared in accordance with IAS-7 'Statement of cash flows' under the indirect method.

2.03 Non-application of going concern assumption

The board of directors has decided to suspend the operation of the company and merge with Ion Exchange Environment Management (BD) Ltd. Hence, going concern assumption has not been applied in preparation of these financial statements.
